A DEVELOPMENT LABORATORY

In order to develop the most appropriate sustainable solutions, we place action-research at the core of our approach.

We test and perfect solutions at local level, before adapting them on a broader scale.

In partnership with national and international research bodies, we produce and share knowledge generated by our experiences to:

- improve development practices;
- influence public policies.



Since 2012, GRET and its partners have been supporting structuring of the milk value chain in the Dagana region in Senegal and helping family livestock farms to improve their living conditions.

- GRET strengthens the capacities of stakeholders (associations, professional organisations, local authorities, small businesses, etc.) to implement locally developed solutions.
- We also facilitate collectives and networks at local, national and international levels.

EMPOWERING LOCAL ECONOMIES

We strengthen the local economic fabric to respond to populations' essential needs through:

- structuring of small and medium businesses and local cooperatives;
- creation and support of social businesses in several countries.



The Nutri'zaza social business, set up by GRET in 2013 to fight against chronic malnutrition in Madagascar, distributes affordable fortified foods suited to the nutritional needs of young children.

THE **COMMONS**

How to ensure equitable and sustainable use of resources, and enable universal access to essential services? The majority of societies are based on competition between two models: public management and private management. GRET strives to demonstrate that an alternative path is possible and can give citizens real power to act.

In some ten countries, GRET is promoting the construction of shared governance whereby citizens, public authorities and businesses learn to decide together on the use and conservation of natural resources and essential services in localities. Through concrete projects and rigorous research, we are building an approach, methods and tools that can be used in development policies.



In Houaphanh province in Laos, GRET provided support to village communities, economic operators and public authorities so that they could learn to co-develop and co-manage economic value chains capable both of conserving bamboo forests and generating income for all.
